Worksheet for Line 5 — Dependents who checked one or both boxes

Use this worksheet to figure the amount to enter on line 5 if someone can claim you (or your spouse if married filing jointly) as a dependent, even if that person chooses not to do so. To find out if someone can claim you as a dependent, see Pub. 501.

A. Amount, if any, from line 1 on front ... B. Minimum standard deduction ... C. Enter the larger of line A or line B here ... D. Maximum standard deduction ... E. Enter the smaller of line C or line D here ... F. Exemption amount ... G. Add lines E and F. Enter the total here and on line 5 on the front

If you did not check any boxes on line 5, enter on line 5 the amount shown below that applies to you. Single, enter \$9,350. Married filing jointly, enter \$18,700.

Worksheet for Line 8 — Making work pay credit

Before you begin: If you can be claimed as a dependent on someone else's return, you do not qualify for this credit. If married filing jointly, include your spouse's amounts with yours when completing this worksheet.

Use this worksheet to figure the amount to enter on line 8 if you cannot be claimed as a dependent on another person's return.

See the instructions on page 12 if (a) you received a taxable scholarship or fellowship grant not reported on a Form W-2, (b) your wages include pay for work performed while an inmate in a penal institution, or (c) you received a pension or annuity from a nonqualified deferred compensation plan or a nongovernmental section 457 plan. Do you (and your spouse if filing jointly) have 2009 wages of more than \$6,451 (\$12,903 if married filing jointly)? 1b. Nontaxable combat pay included on line 1a (see instructions) ... 2.
